Declaration on prohibited substances according to European Directives 2011/65/-EU (-RoHS-), 2015/863 / EU (RoHS2) and EU Chemicals REACH Regulation (EC 1907/2006)

Environmental protection is an essential part of our corporate policy. Environmentally friendly product design and the use of environmentally compatible production processes is the standard for us. The legal requirements for occupational health and safety and environmental protection are observed in the production.

We design our products in such a way that, according to the current state of knowledge, they do not pose any health risk to users and endanger the environment when used as intended.

European Directives 2011/65/EU (RoHS) and 2015/863/EU (RoHS2):

Beta Control s.r.o. products do not fall within the scope of the above directives provided they are used for the intended purpose.

However, Beta Control s.r.o. complies with the prohibitions of substances according to Directives 2011/65/EU (RoHS) and 2015/863/EU (RoHS2) on a voluntary basis. Since 01/07/2006 BC has been producing the entire range in accordance with RoHS.

REACH Regulation EC 1907/2006, which entered into force on 1 June 2007, is a set of Europe-wide regulations for the registration, evaluation, authorisation and restriction of the use of chemicals, whether manufactured, imported or used as other refined or marketed products.

The aim of the regulation is to achieve a high level of protection of health and the environment by minimising the content of hazardous substances in the production and use of chemicals. The regulation defines prohibited substances for certain processes and substances subject to authorisation. In addition, the transmission of information in the supply chain on the content of specific chemicals in products or articles is required.

In particular, substances of very high concern (SVHC) are subject to regulation. Beta Control s.r.o. products do not contain substances of very high concern (SVHC) in a concentration greater than 0.1% of its weight .

Beta Control s.r.o., as a manufacturer of final products and components, does not manufacture substances or preparations and obtains them from the EU or through importers from countries outside the EU. Therefore, our products and components are not subject to registration under REACH.

BC takes on the role of downstream user in the supply chain. We have a policy that our RoHS compliant products should, in principle, also comply with REACH, ie be properly compliant with restricted substances and substances subject to authorisation. As far as SVHC is concerned, we collect and confirm all information we receive from suppliers about the materials and parts used, and we develop individual products accordingly.

However, BC will inform its customers if substances are present in our products in larger than permitted quantities according to REACH Candidate List.
